Nissan Butsuryu Co., Ltd. (Head Office: Chuo-ku, Tokyo; President: NISHIDA Yuji; hereafter “Nissan Butsuryu”) a group company of Nissan Chemical Corporation (Head Office: Chuo-ku, Tokyo; President: YAGI Shinsuke) won the “Excellent Business Entities” in the new development category of the “FY2021 Award for Excellent Business Entities Working on Modal Shift” sponsored by Japan Association Logistics and Transport. The award ceremony was held on Thursday, November 25th.

This award is given to the logistics providers that are making other exemplary efforts under the situation of the growing importance of transportation using mass transport facilities, from the viewpoint of reducing environmental impacts and improving labor productivity in the logistics industry. In addition, this award will broadly introduce the efforts to the public and further promote the modal shift.

This time, Nissan Butsuryu was awarded for achieving two modal shifts from trucks to rail transportation for the transportation of chemical products from Toyama Prefecture to Shimane Prefecture and Yamaguchi Prefecture. In terms of modal shift, they achieved a railroad modal shift through repeated discussions with each person, such as adjusting lead times, thereby reducing CO2 emissions and the burden on truck drivers.

We will continue striving to improve our energy consumption rate through measures such as promoting modal shifts, replacing vehicles with energy-saving and practicing eco-driving.
