# Nissan Chemical and RaQualia Pharma Enter into

## **License Agreement to Research for Neurological Therapeutics**

Nissan Chemical Corporation (Head office: Tokyo, Japan, President: Shinsuke Yagi) and RaQualia Pharma (Head office: Aichi, Japan, President: Masaki Sudo) announced today the signing of a license agreement to research, develop and commercialize novel neurological therapeutics identified by Nissan Chemical.





Nissan Chemical has continued putting efforts into delivering first-in-class therapeutics for neurological disorders using its expertise. RaQualia, on the other hand, has dedicated efforts to expanding its pipeline as an innovative biotech company for future growth. RaQualia has positioned the neurological disorders field as an important pillar and is actively engaged in utilizing innovative modalities and building a new drug discovery value chain.

Under the terms of the agreement, Nissan Chemical grants RaQualia an exclusive global license with sub-license right for certain know-how in the field of neurological disorders. Nissan Chemical will receive an upfront payment, milestone payments based on progress, and royalties on sublicensing.
